In the provice of Punjab alone the percentage of untraced cases was 28.9% during the year 2023. The situation of prosecution in electricity and gas theft cases also portrays very grim picture. This situation depicts wide vacuum, which if filled through professionally competent and timely advice can produce rewarding results.
